# Real Estate Data Call Update






## **Data Request Overview**

- BCFSA requested information from trading services brokerages on transactions between February 19, 2023 – March 18, 2023:
  - **Residential sales**
  - **Rescission notices**




## **Preliminary Highlights**

- Over 1,100 brokerages and branch offices invited to participate
- Approximately two-thirds responded
  - 400+ brokerages reported at least one residential sale during the reporting period
  - >3,000 residential real estate transactions
  - <10% of brokerages reported preparing or receiving at least one rescission notice
  - The balance provided nil responses (i.e., no transactions or rescission notices to report)

## **Overview of Required HBRP Information**

#### PROPERTY **INFORMATION:**

- Civic address
- Parcel ID (PID) number
- Property type

#### **KEY TRANSACTION DATES & DETAILS:**

- Listing price on date of offer acceptance
- Accepted offer price
- Date of offer acceptance
- Whether brokerage represented buyer or seller

#### RESCISSION **NOTICE INFO:**

- Rescission notice date
- Amount of rescission fee

#### **DEPOSIT DETAILS:**


- Whether deposit was provided
- Deposit amount (if applicable)
- If deposit was held in trust account (if applicable)

## How to File

- Reporting template available in IRIS
- Include HBRP information with annual filings
  - Mandatory to report information if your brokerage has received or prepared a rescission notice during your fiscal year
  - If nothing to report, brokerages can opt out
- Can refer to Brokerage Data Call FAQ for questions or contact BCFSA

## **Overview of New Rules**

- Real Estate Services Rules have been amended, effective April 1, 2023
- Key changes to the Rules include:
  - Defining a "real estate team";
  - Requiring all teams to register with BCFSA;
  - Team name must be identified in advertising; and
  - Clarifying business practices and agency relationships.



## **Implementation Highlights**

- In April there were 83 calls regarding the changes to the teams Rules (8.5% of all calls)
- 10-15 per cent of calls to BCFSA Licensing are • related to teams Rules
- Since April 1: 12 teams deregistered, 61 new teams • registered



## Reminders

- Use IRIS to submit all applications (including applications related to teams)
- Team members should submit application on their own behalf
- Managing brokers will still approve applications
- Include correct brokerage licence number on applications

## **AML/PCMLTFA Updates**

#### **MORTGAGE BROKERS**

- Will be designated reporting entities under PCMLTFA on April 1, 2024
  - Reporting obligations will be very similar to those of real estate trading services licensees
    - STRs
    - Large Cash Transaction Reports
    - Large Virtual Currency Transaction Reports
    - Terrorist Property Reports
