# Overview

- BCFSA will be collecting residential real estate data from trading services brokerages
- This Data Call builds on previous year's reporting
- Data Calls are important because they:
  - Support effective oversight
  - Inform BCFSA about risks consumers may be facing
  - Assist in evidence-based policy and regulatory decision-making
  - Allow BCFSA to assess market practices and impact of policy changes




# Key Changes for 2024

- 1. BCFSA will not be collecting HBRP data
- 2. BCFSA will be collecting property address
- 3. Data submissions must be made via IRIS
- 4. Participation in the 2024 Data Call is **mandatory** for all trading services brokerages
  - Non-compliance may be subject to an administrative penalty or other enforcement action
  - Brokerages must still make a submission even if they have no transactions to report

#### **ONLY INCLUDE TRANSACTIONS THAT MEET** <u>ALL</u> THE **FOLLOWING CRITERIA:**

- Your brokerage was the listing brokerage; AND
- The sale was for a residential property; AND 2.
- 3. The firm contract date falls between February 18, 2024, and March 16, 2024.

#### **DO NOT INCLUDE TRANSACTIONS:**

- Where your brokerage only represented the buyer; 1.
- With firm contract dates before February 18, 2024, or after 2. March 16, 2024;
- 3. Of pre-sale units;
- Involving unrepresented sellers;
- Of assignments; or 5.
- Involving commercial or industrial real estate 6.







# Q: How will you be using the collected data?





A: Data assists BCFSA in fulfilling its mandate, specifically in identifying risks consumers may be facing, assisting in evidence-based policy and oversight of licensees. Data enables BCFSA to assess market practices and the impact of policy changes (e.g., Rules.) BCFSA will publish a report in the late spring compiling the results and trends.





## Q: Who needs to respond to the Brokerage data call?





A: Participation in the 2024 Data Call is mandatory for all trading services brokerages. **Brokerages must still make a submission even** if they have no transactions to report.









# Q: What if I have no transactions to report?





A: If you do not have any transactions to report, then you must still submit a workbook that indicates "N" in Column A "Transactions to Report?".





# Q: Do branch offices need to provide a submission?





A: Managing brokers of brokerages are responsible for submitting a single workbook with transactions for their brokerage and any related branch offices. Branches should work with their brokerage to provide a single submission.

A: Brokerages' participation in the 2024 Data Call is mandatory and non-compliance may be subject to an administrative penalty or other enforcement action.
